The Mississauga Nation Territory is connected to the Great Lakes defined by the natural watersheds and land. Amongst many First Nations, the Dish with One Spoon is recognized as a pre-contact agreement which shared the abundances of harvest.

Terms of reference -

MN Coordinators Working Group (MNCWG) July 18, 2017 MN Chiefs appointed a coordinator from each MN to act as the organizing body to move the member Nations forward on their areas of mutual interest. The mandate of the Working Group is to develop united recommendations and if needed, policy for the MN. The Working Group agreed to formalize a regular meeting schedule, with the meetings to be hosted within the traditional territory of one of the member Nation.

The MN Economic Development Officer Collective (EDO Collective) Working Group has a mandate to develop united economic development recommendations for the Mississauga Nation.
